- 1. **The Student Class Schedule** has been reformatted to fit on one page.
- 2. The **Student Information** tabs have been corrected to display complete enrollment information for re-instatements and transfers.
- 3. The **Student Schedule Report** has been modified to show correct schedule changes. Removed or completed classes will not show up.
- 4. The **Class Attendance Roster** and **Class Attendance Report** have been corrected to display students on a biweekly schedule.
- 5. The **CT Provider Lookup** in the Preseparation and Separation screens have been re-formatted to display complete information.
- 6. **Excessive Movement Report** will now display departure date and training days.
- 7. **Projected Separation Report** was corrected to display appropriate data.
- 8. **Enter Transfer Request** will now check for GED and Vocational records instead of when the student arrives on the receiving center. Also in this screen the user will now be allowed to change the approving staff.
