- 1. <u>Purpose</u>. To provide clarity and address frequently asked questions regarding Program Instruction No. 06-29 issued May 10, 2007 (Occupational Exposure to Hexavalent Chromium Standard and Compliance Requirements (29 CFR 1910.1026)). Additionally, this Information Notice removes cement masonry from the compliance requirement; centers are not required to conduct monitoring in cement masonry.
- 2. <u>Background</u>. The National Office of Job Corps issued Program Instruction No. 06-29 to summarize the Occupational Safety and Health Administration's (OSHA's) new hexavalent chromium (Cr(VI)) standard and compliance requirements. This Information Notice provides a step-by-step procedure for conducting air sampling, student and staff monitoring, and analysis of samples; answers frequently asked questions; and illustrates possible center scenarios. This Information Notice must be used in conjunction with Program Instruction No. 06-29.

3. Action.

- a. All Job Corps centers should refer to the attached step-by-step procedure for meeting the compliance requirements described in Program Instruction No. 06-29.
