b. Hospitality Program Clarification – *Reissuance*

As a result of inquiries regarding the issuance of the Culinary Arts and Hotel and Lodging Curriculum Change Notices, the policy for completion of the Hospitality Foundations TAR is as follows:

<u>Current policy for the Culinary Arts program</u>. Completer status is granted only after completion of **both** the Hospitality Foundations TAR 65026JT and Culinary Arts TAR 65026JA.

<u>Current policy for the Hotel and Lodging program</u>. Completer status is granted upon completion of the Hotel and Lodging TAR 53808JA only. **Note:** Hotel and Lodging programs that offer both "front of the house" and "back of the house" training are highly encouraged to use the Hospitality Foundations TAR, 65026JT.

3. <u>Action</u>. Addressees are to ensure that this Information Notice is distributed to all appropriate staff.

4. <u>Expiration Date</u>. This issuance serves as the second quarterly report, with the subsequent issuances in March and July 2009.
