SUBJECT: Updated Training Opportunities Directory

1. Purpose. To (1) enable the Job Corps community to identify the career technical training opportunities available for current and prospective students at each of the 123 Job Corps centers; and (2) inform the centers how to submit changes to the information for semi-annual updates.

2. Background. The Training Opportunities Directory (TOD) helps the Job Corps community keep abreast of changes in the career technical training offerings at each center. This information enables students to determine which Job Corps center would best support their training and career goals.

The TOD is a living document that will be updated twice a year and posted on the Job Corps Community Web site. Regional points of contact (POCs) will receive updated information from centers about changes to their career technical training offerings. The POCs will pass this information on to the National Office of Job Corps to be included in the next issue of the TOD.

- d. An updated TOD will be posted on the Job Corps Community Web site semi-annually, on March 1 and September 1.
