- 1. <u>Purpose</u>. To inform Job Corps centers about the next Quarterly Safety Forum hosted by the Office of Job Corps (OJC).
- 2. <u>Background</u>. The Office of Job Corps' Quarterly Safety Open Forum is designed to provide centers the opportunity to express ideas and concerns regarding the Job Corps safety program. Members of the OJC safety team will be available to answer questions, and to provide feedback on various policy issues, recent regulatory changes, and future Job Corps safety activities. The next Quarterly Safety Open Forum is scheduled for Wednesday, February 20, 2013.
