SUBJECT:	High School Equivalency Materials on the Job Corps Community Website

- 1. <u>Purpose</u>. To announce inclusion of High School Equivalency (HSE) testing information on the Job Corps Community website.
- 2. <u>Background</u>. Information on HSE testing is changing rapidly and will continue to develop until the release of new HSE assessments in January 2014. To provide a consolidated source of information for centers, the Office of Job Corps has established a "High School Equivalency" component of the Job Corps Community website's "Academic Training" sub-site. With this HSE component, centers will be able to access updates on HSE testing on an on-going basis, and link directly to related resources.
- 3. <u>The High School Equivalency component of the Job Corps Community website will</u> include:
 - HSE test information and links to the websites of the three tests the 2014 GED, the TASC (Test Assessing Secondary Completion), the HiSET (High School Equivalency Test);
 - Recent news about HSE testing and a calendar of events of major training opportunities, conferences and meetings;
 - Professional development opportunities offered online through test providers and educational organizations;
 - Curricula and other related resources to help students with test preparation;
 - Job Corps webinar schedules and slides from webinar presentations;

- Policy updates including links to Job Corps Information Notices, U.S. Department of Labor Notices, and Job Corps PRH Change Notices;
- Updates on states' selections of high school equivalency tests;
- Frequently Asked Questions (FAQ) and answers.
- 4. <u>Action</u>. Center and operator personnel should access the HSE component of the Job Corps Community website by taking the following steps:
 - Log on to the Job Corps Community website using your Citrix credentials and locate the navigation menu on the left of the Home Page.
 - Click on the Academic Training menu item (under Career Development).
 - Then click on the High School Equivalency link. (between Policy and Academic Web Links)
