Photo Guidelines:

- Nominee should be wearing her training uniform, including safety gear like goggles, mask, or helmet. Note: If her training uniform includes safety gear such as mask or helmet, please make sure it is not pulled down over her face. She can be holding it to the side, or it can be pulled up on her head.
- Nominee should be standing against a simple, plain backdrop like a white wall in a classroom or the side of a brick building.
- Nominee should be standing with both hands on her hips.
- Please have the nominee remove any facial jewelry, including nose rings, lip rings, and earrings.
- Make sure the nominee does not have any visible tattoos in the picture.
- The photo should be taken of the student from the waist up.
- The photo should be high-resolution, and at least 600 pixels wide.
