SUBJECT:	Upcoming Student Conduct Webinars for Operators and Center Staff

- 1. <u>Purpose</u>. To inform the Job Corps community of upcoming webinars for operators and center staff on policy changes regarding Student Conduct and Zero Tolerance.
- 2. <u>Background</u>. Policy and Requirements Handbook (PRH) Change Notice 15-09, published in February 2016, notified the field of impending changes to the PRH on Student Conduct and Zero Tolerance. The changes are intended to more clearly define misconduct to ensure infractions are properly classified and addressed. This includes providing specific definitions for and/or examples of serious infractions.

As these changes will soon be released in the Student Conduct module in the Center Information System (CIS), the National Office is offering Webinars for operators and center staff to familiarize themselves with the changes that will take effect June 1, 2016.
