SUDJECT.	Behavior and the Job Corps Student Conduct Policy During Admissions
	and Pre-Enrollment

1. <u>Purpose</u>. To notify the Job Corps community of new Spanish-language versions of three videos about student conduct for use during the application and pre-enrollment phase.

2. <u>Background</u>. The Workforce Investment and Opportunity Act and Job Corps' updated student-conduct policy identified a need for applicants to know what to expect from, and while in, the program. To support that effort, a video series entitled *Great Expectations* will share messages that emphasize being safe and secure, knowing the rules, and staying focused on career goals. The videos feature Job Corps students, and address common questions related to living and training on-center.

The Job Corps National Director introduced the *Great Expectations* video series in her August 2016 national newsletter.

3. <u>Action</u>. Outreach and Admissions staff members shall incorporate the three-part series into the application and pre-enrollment processes. Spanish versions of the videos are available for Spanish-speaking applicants. The videos are available via the following links, and staff members must show the videos in the order below.
