SUBJECT: PRH Chapter 5: Update and Revision to Appendix 501 Introduction,

and Appendix 501a: Policies and Procedures for PY 2004 Center

Report Card and Center Quality Report Card

1. <u>Purpose</u>. To transmit revisions of the PRH, Chapter 5, Appendix 501 Introduction, and Appendix 501a, as outlined in the National Director's memorandum dated August 11, 2004. These appendices contain an introduction to Job Corps' performance management system and policies for the centers' outcome management system (OMS).

2. <u>Background</u>. In response to feedback from the Job Corps community, the National Director has reviewed a number of issues related to the OMS literacy and numeracy gains measures, as originally communicated in PRH Change Notice No. 04-01, dated July 1, 2004.

Literacy and numeracy gains are important measures, and they will continue to be tracked and reported on the Center Report Card. However, it has been decided that for PY 2004, the weight attributed to both literacy and numeracy would be removed and redistributed to other direct center measures. In this scenario, direct center services will continue to be 30% of the overall Center Report Card, as follows:

- 60-day Commitment Rate will remain at 5%
- GED/HSD Attainment Rate will be 12.5%
- Vocational Completion Rate will be 12.5%

Again, literacy and numeracy gain measures will continue to be reported on the Center Report Card for informational purposes, and model-based goals will be included in order for centers to track their progress against goals. Because the literacy and numeracy measures will not be weighted (but they will be reported) in PY 2004, the Center Report Card will continue to be a separation-based rolling report for <u>all measures</u>.

3. Explanation of Changes. Changes to the PRH Chapter 5, Appendices 501 Introduction and 501a revise the Center Report Card to remove the weight assigned to the literacy and numeracy gain measures in PRH Change Notice No. 04-01, dated July 1, 2004, and redistribute this weight to the other direct center measures. Literacy and numeracy gain measures will be reported in a 12-month rolling report format in the PY 2004 Center Report Card for informational purposes only, and model-based goals will be included in order for centers to track their progress against goals. The outcomes captured this Program Year will be part of the weighted measures for the July 1, 2005 rolling Center Report Card.
