SUBJECT: Policy and Requirements Handbook (PRH) Chapter 1, Section 1.2, R8,

Essential Admissions Requirements, Exhibit 1-1, and Addition of

1. <u>Purpose</u>. To align the Job Corps definition of eligible homeless youth with the McKinney-Vento Homeless Assistance Act as amended by S.896 – The Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act of 2009.

- 2. <u>Background</u>. The McKinney-Vento Homeless Assistance Act was established to engage the federal government in addressing the needs of the homeless, a largely under-represented population throughout the country. The Act acknowledges homelessness as a national problem, requiring a range of services to lower the homeless rate and strive for prevention. Services to be afforded include: job training; primary health; education; and permanent housing.
- 3. <u>Reference</u>. McKinney-Vento Homeless Assistance Act as amended by S.896 The Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act of 2009.
- 4. Explanation of Change(s).
  - a. <u>PRH Chapter 1, Section 1.2, R8</u>. Essential Admissions Requirements, incorporate the definitions of "homeless," "homeless individual," and "homeless person" from the McKinney-Vento legislation.
  - b. <u>Appendix 109</u> contains the entire Act, and has been added as a reference for Admissions Counselors.
- 5. Explanation of PAG Change.

<u>PAG Chapter 1, Section 1.2, R7</u>. Essential Admissions Requirements has been updated to reflect the change to the PRH.

- 6. <u>Action</u>. Addressees are to ensure this Change Notice is distributed to all appropriate staff.
