- 1. <u>Purpose</u>. To provide updates regarding the changes to Appendix 303 Career Technical Skills Training (CTST), Appendix 303a CTST Instructions for Completing the CTST Form, and Appendix 303b CTST Sample Project Descriptions in the Policy Requirements Handbook.
- 2. <u>Background</u>. The National Office of Job Corps has implemented a new form and process for centers to apply for CTST funding for the Program Year (PY) 2017 cycle. Consequently, Appendices 303, 303a, and 303b have been revised to provide guidance on the new process.
- 3. Explanation of Change(s). The National Office of Job Corps integrated CTST Forms 1, 2, and 3 into a new CTST form that will be used by the centers to describe individual CTST projects, to request CTST annual funding, and to reconcile CTST funding, at least, biannually. Appendices 303, 303a, and 303b provide guidance for completing the new form, and have been updated accordingly. The changes are as follows:
 - Appendix 303 Defines CTST-related general requirements and programs eligible for CTST funding, describes CTST plan details, the submission and approval process, and the operation of CTST projects.
 - Appendix 303a Provides instructions for the completion of the new CTST form, which is posted on the Job Corps Construction Rehabilitation and Acquisition (CRA) Funded-Not-Corrected (FNC) Web site.
 - Appendix 303b Provides examples of CTST project descriptions.
