- 1. <u>Purpose</u>. This notice describes a revision to Job Corps' policy on the amount of the transition allowance (also referred to as "transition payment") paid to enrollees at the time of graduation.
- 2. <u>Background</u>. Job Corps uses the transition allowance to incentivize attainment of academic and career technical training (CTT) credentials by enrollees.<sup>1</sup> Applicants are informed upon enrollment that they may be eligible for a transition allowance when they graduate. However, to be eligible, enrollees must graduate with a combination of either a High School Equivalency (HSE) or a High School Diploma (HSD) and a CTT credential. Job Corps is permitted to make adjustments to the amount of the allowance as appropriate. Currently, Job Corps' transition allowance is \$1,000.
- 3. <u>Explanation of Change(s)</u>. This notice announces an increase in the transition allowance from \$1,000 to \$1,200. This increase further incentivizes enrollees by providing additional funds for transition related expenses when they graduate with a HSE or HSD and a CTT credential. The requirement that the completion of these achievements must be through the Job Corps program remains unchanged.
