SUBJECT:	Policy and Requirements Handbook Revisions to Career Transition Services Policy

- Purpose. This notice describes revisions to Job Corps' Career Transition Services Policy in Chapter 4 and Appendix 501/501B.
- 2. <u>Background</u>. The Office of Job Corps is revising its policies to align with the transition of Job Corps' Career Transition Services (CTS) from a geographic-based placement system to a center-based placement system. Under the new center-based placement approach, job placement and follow-up services provided by the center will cultivate higher quality job leads with local employer partners, relevant job placement prior to departure, and seamless communication for follow-up services with the student.

### 3. Explanation of Change(s).

Chapter 4 – Career Transition Period

#### Section 4.1 - Career Transition Period Plan

- Language was changed in R1.c.2(b) by removing, "geographic area(s) to be served" and revising the requirement to "where staff will be deployed to provide center-based placement services."
- Language was deleted in R1.c.3(h) that addressed arranging continuing services for graduates and former enrollees who relocate. In a center-based placement system, the CTS service provider will not change when a graduate or former enrollee relocates.

Section 4.3 - Career Transition Period Plan

Requirement R5. Relocations was deleted because graduates and former enrollees
who relocate will continue to receive placement services from the same service
provider and will not be transferred to another service provider.
