SUBJECT: Policy and Requirements Handbook (PRH) Update on Authorized Off-

Center Training Activities and Programs

- Purpose. To update the requirements for all authorized off-center training activities such 1. as Work-Based Learning and to include provisions for the Public Lands Corps (PLC) Program, exclusive to USDA Forest Service Centers.
- Background. As part of Job Corps' initiative to modernize policy and adhere to the development of workplace skills, Job Corps is updating authorized off-center training sections of the PRH, including Work-Based Learning (WBL) standards in Section 3.3 R6.a and Exhibit 6-1, "Duty/Pay/Leave Status." Job Corps has continued to add programs and models (PLC, for example) that incorporate authorized career-related, off-center training activities to prepare students for workplace success. As a result, policy language needed to be broadened to capture this expanded focus.
- 3. Explanation of Changes. This change notice transmits the following changes to the Policy and Requirements Handbook (PRH) modifying the Work-Based Learning Program standards, and the Student Leave policy.

## Chapter 3, Section 3.3 R6.a Work-Based Learning Program and Chapter 6, Exhibit 6-1, Duty/Pay/Leave Status Chart

Language was added to increase the opportunity to participate in WBL for an additional 10 weeks for a total of 16 weeks with regional approval. This provision is authorized to support the USDA Forest Service PLC Program exclusively.

- Language was added at the Present for Duty Off-Center sections of the chart that is reflective of all authorized career-related training activity.
- "Criteria/Limitations" were added to the Present for Duty Off-Center sections to allow for expanded periods of off-center and overnight stays for WBL and Fire-Fighting authorized training activities
- 4. <u>Action Required</u>. Addressees are to ensure this Change Notice is distributed to all appropriate staff.
- 5. <u>Effective Date.</u> Immediately.
