SUBJECT: Job Corps' Fuel Reduction Initiative

1. <u>Purpose</u>. To inform the Job Corps community of the two new processes being implemented to meet the goals of the Fuel Reduction Initiative and to provide helpful information on the Initiative.

2. <u>Background</u>. On April 20, 2000, Executive Order (E.O.) 13149, was issued to direct federal agencies to reduce petroleum fuel consumption by 20 percent by FY 2005 through improvements in fuel efficiency, and the use of alternative fuel vehicles (AFVs) and alternative fuels. E.O. 13149 mandates that the reduction in fuel consumption be 20 percent of the consumption amounts for FY 2000. To date, Job Corps has reduced its fuel consumption by 15 percent.

3. Job Corps Fleet Management System. In the past, the National Office has collected fleet data from centers bi-annually. The Assistant Secretary of Administration and Management (OASAM) is requiring that fleet data be collected on a monthly basis. To facilitate this monthly reporting process, the Job Corps Fleet Management System has been developed using a Web-based database, which is located at http://jcfleet.exceedcorporation.com. The first reporting period specifically should be used as an opportunity for each center to validate the fleet information that is in the system to ensure that it is accurate. The first monthly report (for June 2005) is due on July 20, 2005 with all subsequent reports due on the 10th day of the next month. For example, the monthly report for July 2005 will be due on August 10, 2005.

Each center has a unique username and password for entrance into the Web site. To obtain a username and password, each Center Director must send an email to the system administrator, Latoya Jones at <u>ljones@exceedcorporation.com</u> providing contact information for the center's fleet point of contact (POC). Upon receipt of that email the administrator will send both the Center Director and the fleet POC the username and password required to enter the Web site.

The Job Corps Fleet Management User Guide has been created to facilitate use of this system. A copy of the Guide is provided as Attachment A. It is also located at http://jcfleet.exceedcorporation.com.

4. <u>New Vehicle Acquisition Clearance Process</u>. The acquisition of alternative fuel vehicles (AFVs) is vital to meeting the petroleum fuel reduction goals established in E.O. 13149. A recent review of the Department of Labor's (DOL) fleet indicates that, while progress is being made, the acquisition of AFVs remains insufficient to meet established goals. OASAM has instituted a new clearance process for new vehicle acquisitions and lease renewals requiring all agencies acquire AFVs where possible.

The acquisition of any non-AFVs must be approved by OASAM. Job Corps centers wishing to acquire a non-AFV vehicle must submit, in writing to the Regional Director, a justification for the acquisition. The Regional Director will then forward the request to the National Office of Job Corps, Attention: Sandra Darden. Upon approval or disapproval by OASAM, the Regional Director will be sent an email notification advising them of the decision by OASAM. OASAM Fleet Manager will facilitate the acquisition. When acquiring any new vehicles or renewing any existing leases, the agency code "1680" should be used to complete all necessary paperwork.

5. <u>Fuel Initiative Briefing Package</u>. The Fuel Initiative Briefing Package has been developed to provide background on the Fuel Reduction Initiative. The package includes information on alternative fuels, the rationale for efficient fuel usage, best practices, additional information resources, and technical assistance. It is provided as Attachment B.
