SUBJECT: 2015 Summer Break, and 2015-16 Winter Break

1. Purpose. To provide the dates for the 2015 Summer Break, and the 2015-16 Winter Break.
2. Background. In the spring of 1999, the National Director convened a workgroup to recommend operational cost savings and efficiencies. One recommendation was to provide for two annual student breaks. The breaks allow students to be home while others their age are also out of school. In addition, centers can use this time for staff training, and physical plant and equipment maintenance.
3. Reference. Program Instruction Notice 13-31.
4. Action. The 2015 Summer Break will be 18 consecutive days, including 12 weekdays, the Fourth of July holiday, and three weekends. This year's Summer Break will begin Friday, June 26, 2015, (normal classes end Thursday, June 25, 2015), and continue through Monday, July 13, 2015, (normal classes resume Tuesday, July 14, 2015). Summer break days are unpaid leave.

Centers should mark these days as non-training days in their Center Information System (CIS) calendars.

A double pay will be available to students for the pay periods ending June 12, 2015, and June 26, 2015. Funds for these pay periods will be available for disbursement to all students June 19, 2015, while students are still on center. Funds for the pay period ending July 10, 2015, which will consist of only uncollected pay, will be available at Job Corps center banks July 17, 2015. Funds for the pay period ending July 24, 2015, which will consist of 11 paid days, will be available at Job Corps center banks July 31, 2015.

The 2015-16 Winter Break will be 21 consecutive days, including 15 weekdays, the Christmas and New Year's holidays, and three weekends. This year's Winter Break will begin Thursday, December 17, 2015, (normal classes end Wednesday, December 16, 2015), and continue through Wednesday, January 6, 2016, (normal classes resume Thursday, January 7, 2016). Winter break days are unpaid leave.

Centers should mark these days as non-training days in their CIS calendars.

A double pay will be available to students for the pay periods ending November 27, 2015, and December 11, 2015. Funds for these pay periods will be available for disbursement to all students December 4, 2015, while students are still on center. Funds for the pay period ending December 25, 2015, which will consist of 5 paid days, will be available at Job Corps center banks December 31, 2015. Funds for the pay period ending January 8, 2016, which will consist of 2 paid days, will be available at Job Corps center banks January 15, 2016.

Center Directors are to ensure this Program Instruction Notice is distributed to all appropriate staff.
