	Webinars and Exam Update for Career Technical Training (CTT)

- 1. <u>Purpose</u>. To inform the Job Corps community of upcoming Webinars to prepare students for the NHA certification exams. Additionally, to announce changes to the Certified Medical Administrative Assistant exam.
- 2. <u>Background</u>. In Program Year 2013, credential attainment peaked at 93.9 percent nationally, an indicator that the Job Corps community is taking strong measures to ensure students are prepared for certification testing, and yield successful results. The quality of instruction and use of online resources and practice exams, coupled with active credential partner engagement, contribute to this high achievement.

However, a recent analysis shows there are many centers not using certification prep materials, and they could benefit from utilizing online resources and practice exams to improve their credential attainment rate. The use of these resources shows students passing their test on the first attempt, which in turn saves money and time, and improves a student's preparation for future certifications.

The NHA, which offers credentials aligned with Clinical Medical Assistant, Electronic Health Records, Insurance Claims Processor, Medical Administrative Assistant, Patient Care Technician, and Pharmacy Technician, will be providing training on its certification preparatory materials to increase and strengthen certification attainment. Healthcare instructors who teach these training programs are highly encouraged to attend. The goal for this training is to increase awareness, provide access to training, as well as share best practices.

ATI Allied Health, in partnership with NHA, offers innovative certification exam Study Guide Tutorials delivered via its allied health portal, an online resource that uses the best of

Internet-based learning technology to provide an optimum learning experience. The allied health portal engages students through rich animation, video and other interactive tools, which assist in learning and knowledge retention.

These capabilities accommodate different learning styles, improve student comprehension and retention, and ultimately lead to better-prepared certification candidates. A 2013 ATI Allied Health and NHA research study has shown a clear predictive link between above-average scores on ATI Allied Health practice exams and a passing score on five different NHA certification exams.

The Study Guide Tutorials feature the following:

- Lessons, practice drills, and review questions
- Alignment to certification test plans
- Audio and video introductions, case studies and summaries
- Online practice assessments with rational assessing basic comprehension and mastery of key principles
